



WESTBURY JEEP CHRYSLER DOGDE RAM – GREAT AMERICAN JEEP GIVEAWAY NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Contest is open only to those United States Veterans who are nominated at the [www.JeepsThatRock.com] and who are 18 years of age or older and possess a valid New York State driver’s license as of the date of entry. The Contest is only open to legal residents of New York State and is void where prohibited by law. Employees of Westbury Jeep Chrysler Dodge Ram (“WJCDR” or “Company”), its affiliates, subsidiaries, advertising and promotion agencies, and WJCDR’s suppliers, (collectively the “Employees”), and their immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. The Contest is void where prohibited.

The entry must be completely filled out and describe why the Veteran who you are nominating should win this Contest. A description of the Veteran’s service and his or her current need should be included. You may include anything else that will help the Judges decide who the finalists are. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of WJCDR. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of WJCDR.
